ECP appears to have modified result forms of many constituencies of the Punjab province.

Islamabad, 5th July: Since the issuance of Pattan-Coalition38 Press Release on 3rd July about Form-45s & 46s of Lahore constituencies, the ECP appears to have modified or changed the result forms on its website of the following constituencies. Our audit team is trying to find out if there are any reasons for the modification.

The following table is based on the Google-Drive data which was available till 1:30 PM, 5th July 2024. The Elections Act 2017 appears to bar the ECP from changing election result/s forms once final consolidated results are announced through Form-49, unless courts or tribunals allow the recount.

Reading of the Google Drive folders of the ECP appears to show that modification had taken place in 12 NA constituencies (all fall in Punjab), and 21 of PP constituencies of the same province modification.

Our audit team is probing result forms of other provinces, and we will share the results in due course.
